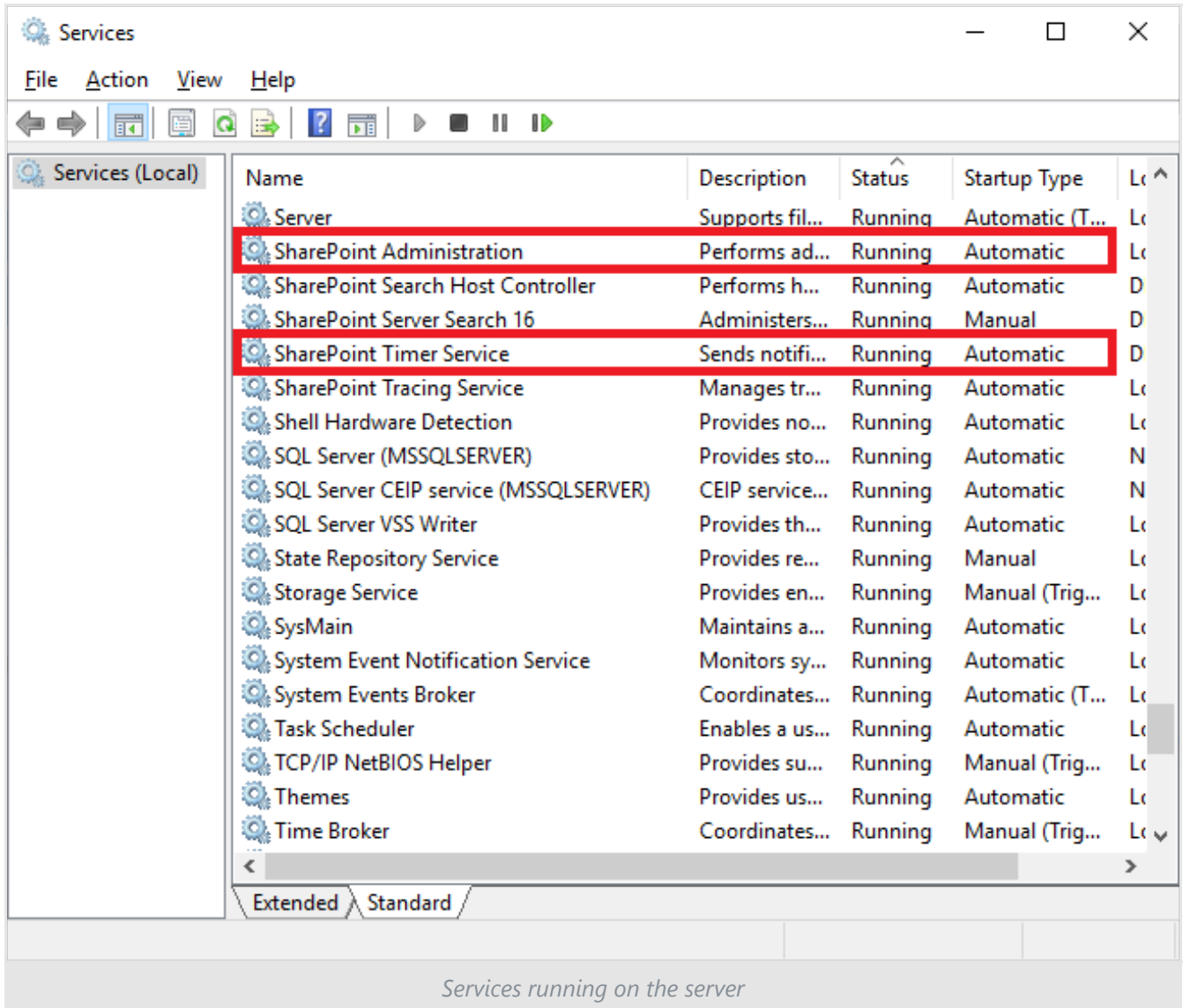

## Preconditions

### SharePoint Services

Before the installation process, please make sure these services are running on the SharePoint Server:

- SharePoint Administration
- SharePoint Timer Service



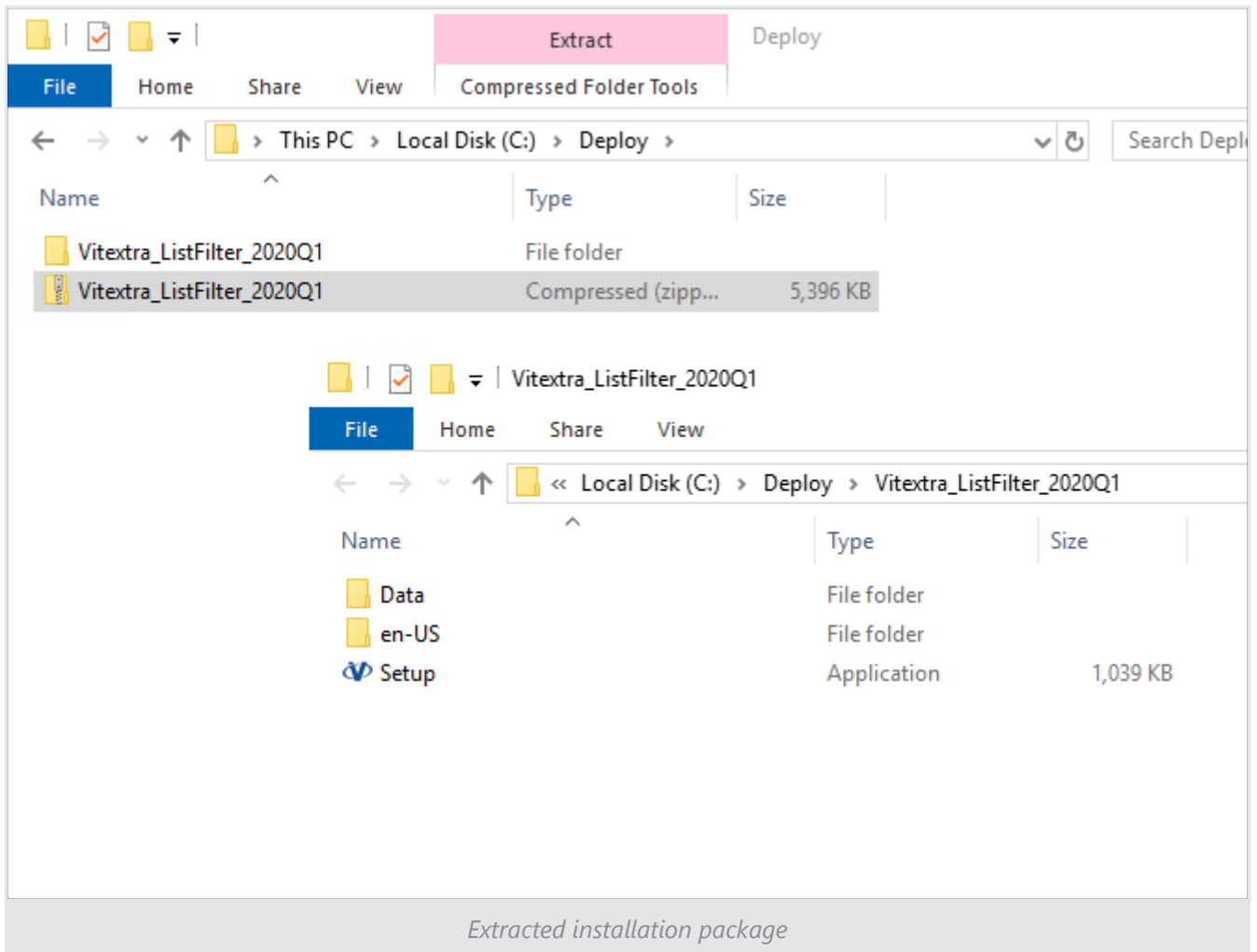
## Required Permissions

To perform the installation procedure, you must have the following permissions and rights:

- Member of the local server' Administrators group
- Member of the Farm Administrators group

## Installation package

Download the zip file (\*.zip) of the product from the [downloads page](#) and unpack it to the SharePoint Front-End server where the installation process will be performed.



### **Warning**

Do not install Vitextra .wsp files directly with PowerShell or STSADM.

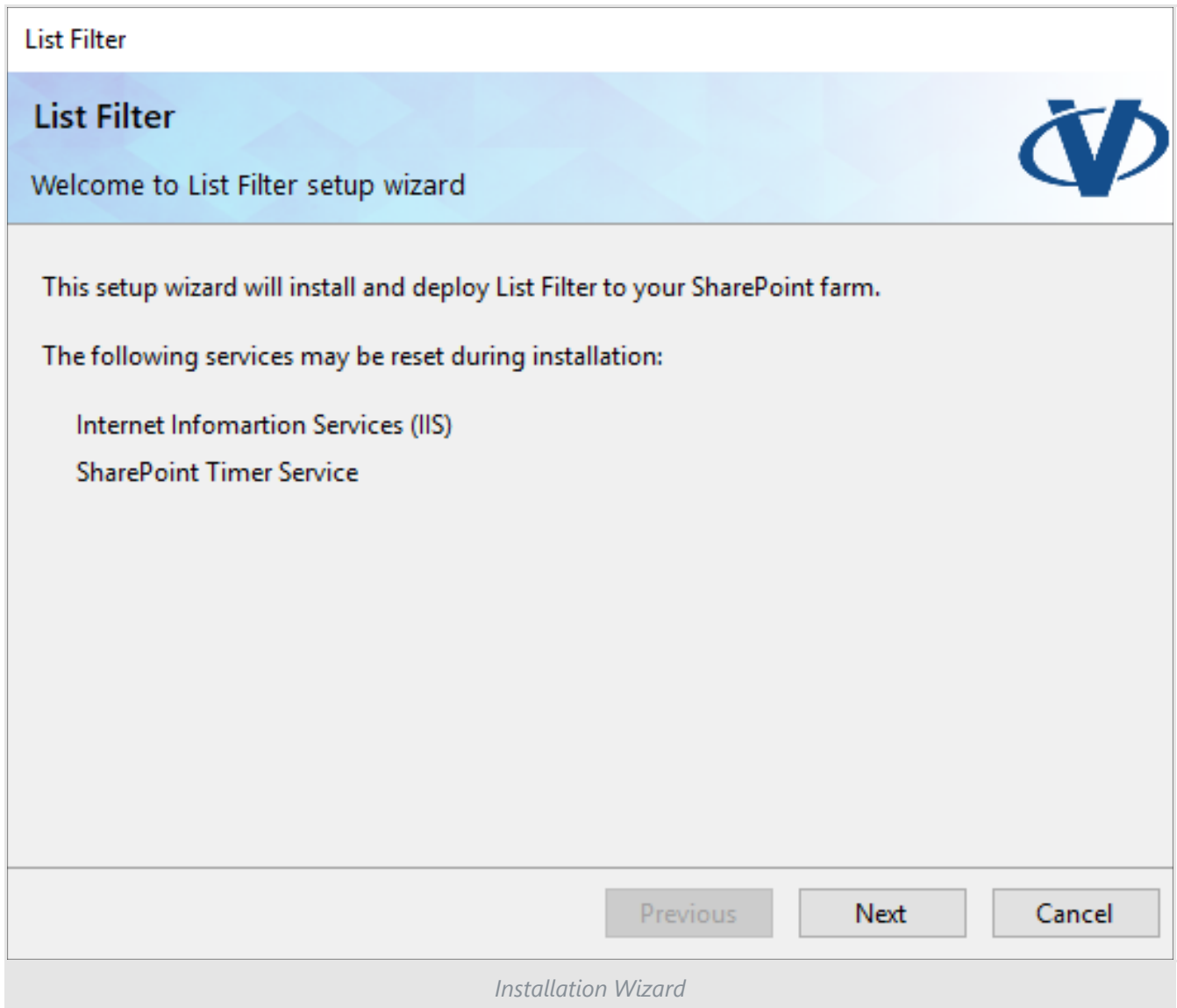
## Installation

Open the folder where you have an installation package and run the Setup.exe file.

### **Note**

If you could not run the setup file, right-click the Setup.exe file and select *Run as administrator*.

Installation wizard will appear as shown below:




Click on **Next** to start the checking process to verify the server meets all the requirements for product installation.

After system check is finished, click **Next**.

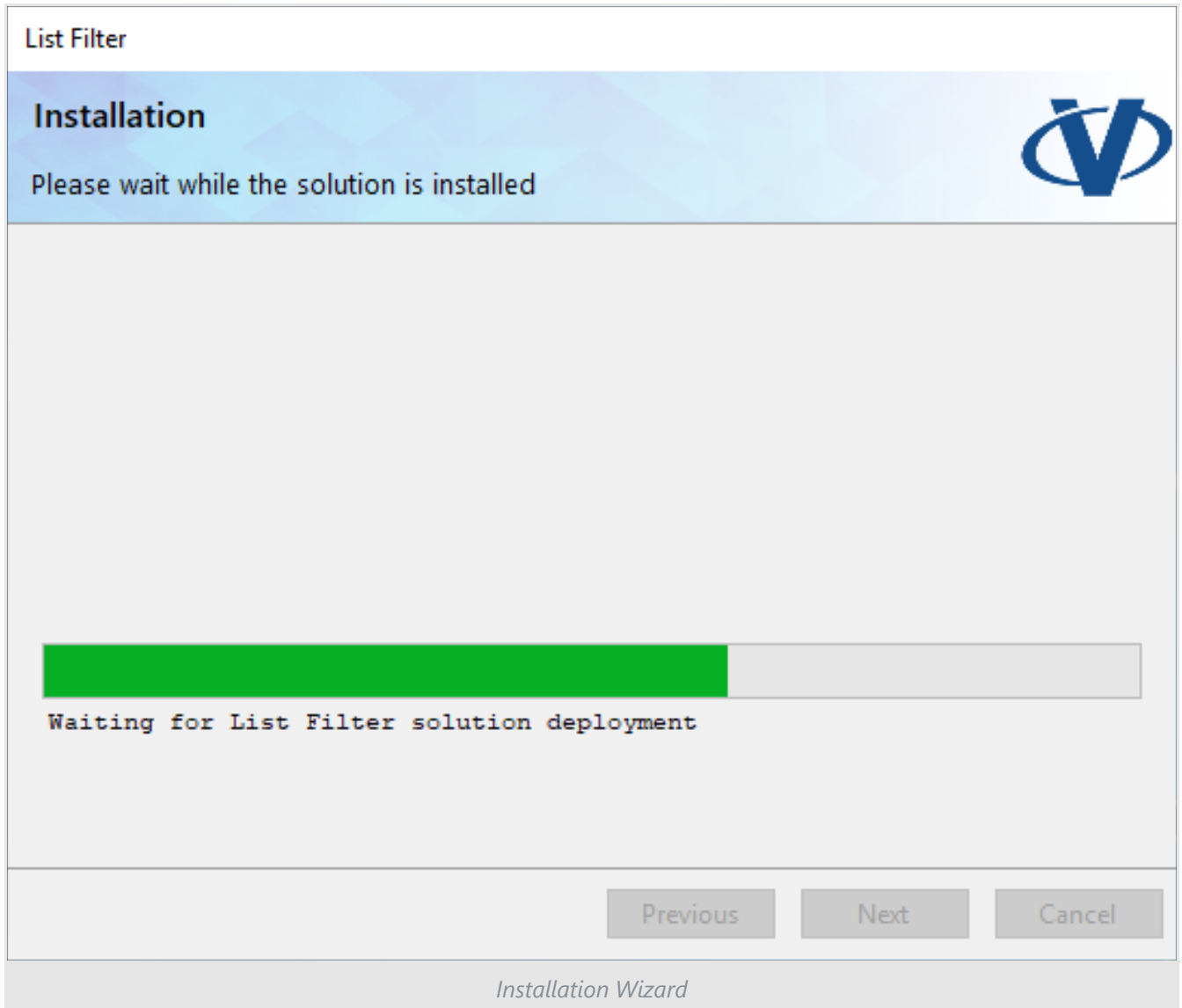
